Dr.S.A.Suryanwanshi suggested collaboration with industry with funding for one or two courses. Sri D.Ramakrishna proposed German Model of Skill Development and suggested to identify a Coordinator to interact with Sri D.Ramakrishna and he also proposed industry exposure of one week to one month to faculty members also.

08. Admissions made discipline wise as against the approved intake of AICTE.

Admissions made during the year 2014-15:

UG: B.Tech. 671 students are admitted as against sanctioned intake 690 B.Tech. (LE) – 109 students are admitted as against 150 sanctioned intake.

PG: 175 students are admitted as against sanctioned intake 210.
