- (b) Lab Setup: The College will provide space in there existing lab to set up "<u>Texas</u> <u>Instruments Embedded Systems Lab</u>" or "<u>Texas Instruments Microcontroller Lab</u>" at its premises. Cranes agrees to donate development kits based on <u>Texas</u> <u>Instruments MSP430 Microcontrollers</u> worth Rs.<u>60,000./-</u> to the college Laboratory under TI India University Program to setup Texas Instruments Embedded Systems Lab. Cranes, working with TI India, will also provide the branding materials to set up the lab – e.g. posters and nameplates. The College will be responsible for purchasing any other equipment required for setting up the lab and for the maintenance of the lab. - (b) Lab Setup: The College will set up a lab which will be entitled "<u>Texas</u> <u>Instruments Analog Systems Lab</u>". Cranes agrees to donate 6 setups of Analog System Lab Starter Kits (ASLKv2010 Starter Kit) developed at Texas Instruments India to the college. Cranes, working with TI India, will also provide the branding materials to set up the lab – e.g. posters and nameplates. The College will be responsible for purchasing any other equipment required for setting up the lab and for the maintenance of the lab. Cranes agrees to set up the lab and provide the necessary initial training and learning materials to begin the instruction.

- (c) Curriculum: The College will introduce a <u>lab-based course using Texas</u> <u>Instruments ASLKv2010 Starter Kit</u> in their <u>undergraduate engineering</u> <u>curriculum</u>. The college will also explore other ways to introduce ASLKv2010 Starter Kit in their curriculum e.g. postgraduate curriculum.
- (d) <u>Faculty Development Program</u>: The College will organize at least one <u>faculty</u> <u>development program</u> at the premises of the college to <u>help its own faculty</u> <u>members and the faculty members from other Indian colleges to teach analog</u> <u>system design using ASLKv2010 Starter Kit</u>. The College will provide the infrastructure facility for conducting such a <u>faculty development program</u>. Cranes reserves the right to open the training to other organizations in the region.
- (e) Workshops/Events: If the College wishes to organize a national event in the area of analog system design, Cranes will provide speakers.
- (f) **Training Programs**: Cranes will assist the college in organizing training programs/tutorials on topics related to Analog System Design. Faculty members from the college who have undergone train-the-trainer program at Cranes and who are certified by Cranes as trainers may run paid Cranes-certified training programs. Cranes will provide certificates for the participants of such programs. Faculty member from the institution must run at least on train-the-trainer program in a year on ASLKv2010 Starter Kit for external faculty and submit the report to Cranes.

AND

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS FOLLOWS :

- 1. It is agreed with the First Party that the second party shall coordinate for smooth conducting of On-Campus training classes to students detailed in the proposal.
- 2. In This type of On-Campus Training the duration of training will be three days in which two days are allotted for theory at College premises and the third day is allotted for visit of exchanges in Vijayawada city for which college authorities have to arrange conveyance to the participants.
- 3. First Party will arrange required facilities to conduct training classes at the college premises for the registered candidates.
- 4. The Topics covered under On-campus training IP technologies, IP Addressing, Broadband and Networking, Software implemented in BSNL, MPLS-VPN Technologies, Latest Data Services in Telecom, Optical Transmission of Data. Mobile Data Services, Switching Technologies, GSM/CDMA Mobile Technologies, OF Transmission Technologies of voice and data, Telecom Infrastructure, Advanced Telecom services.

- 5. As per the BSNL existing norms, fee will be collected from interested candidates.
- 6. After completion of training programme, certificate will be issued to the all participants.
- 7. This agreement is valid for a period of **three years** from the date of the agreement and can be renewed subject to the terms and conditions in force of both parties.
