- Hall Tickets will be issued only to the eligible candidates who fulfill the academic requirements of the Institute. Mere payment of examination fee and submission of application form for semester end examinations does not entitle the candidate to become eligible for attending the semester end examinations unless he/she satisfies the requisite academic regulations.
- 100% Examination Fee Exemption for physically challenged students and they must submit the duly attested medical certificates as a proof.**

- Online Submission of Application and fee payment can be done from <https://student.pvpsitonline.in> (no need to submit application or online transaction receipt). However students are requested to save the copy of online transaction copy in case of any mishap. *Mere deduction of amount from your account does not entitle for payment of examination fees, generation of Online payment copy slip in the software (Under Payment Receipt Tab) confirms to applying for Examination.*
- The Student User Name and Password for Online Application and Payment of fee are available with Exam Section. Students having problems in non generation of payment process/ non generation of Transaction Receipt are requested to report immediately to Office of Controller of Examinations(Room No: 402).
- Offline Applications for Regular/Supplementary examinations & fee challans (yellow color) are available at the office of Assistant Controller of Examinations (i.e. Ground Floor Exam Cell Room No: 106).
- For Offline payment of Regular/ Supplementary Examinations, filled in applications along with fee paid challans (i.e. With/ Without fine) have to be submitted to the Assistant Controller of Examinations (Room No.106). Fee has to be paid at Syndicate Bank VRSEC Branch. Offline Application will not be accepted after the date given in the above schedule, even though the candidate had paid the examination fee.**
- Fee has to be paid separately for every appearing semester end examination.
- Students who have completed six year duration (MCA students) from the year of admission, will be eligible to write the examinations only after obtaining the permission from JNTUK.**
