- Hall Tickets will be issued only to the eligible candidates who fulfill the academic requirements of the Institute. Mere payment of examination fee and submission of application form for semester end examinations does not entitle the candidate to become eligible for attending the semester end examinations unless he/she satisfies the requisite academic regulations.
- 100% Examination Fee Exemption for physically challenged students and they must submit the duly attested medical certificates as a proof.**

- Online Submission of Application and fee payment can be done from <https://student.pvpsitonline.in> (no need to submit application or online transaction receipt). However students are requested to save the copy of online transaction copy in case of any mishap. *Mere deduction of amount from your account does not entitle for payment of examination fees, generation of Online payment copy slip in the software (Under Payment Receipt Tab) confirms to applying for Examination. Students are requested not to pay the exam fee using Mobile Phones, kindly use Desktop/Laptop for payment of Exam Fees.*
- Students having problems in generation of payment process / non generation of Transaction Receipt are requested to report immediately to Office of Controller of Examinations (Room No: 402).
- Offline Applications for Examinations & fee challans (yellow color) are available at the Office of Assistant Controller of Examinations (i.e. Ground Floor Exam Cell Room No: 106). Fee has to be paid at Syndicate Bank VRSEC Branch. Offline Application will not be accepted after the date given in the above schedule, even though the candidate had paid the examination fee.
- Students who have completed eight year duration (regular students) and six year duration (lateral entry students) from the year of admission, will be eligible to write the examinations only after obtaining the permission from JNTUK.
- Students who have not submitted PC application form, CGC sheet, attested xerox copies of SSC, Semester End Grade Cards, AADHAAR cards and satisfied academic requirements will not be processed for issue of PC by University. In case university increase the PC fee, student have to pay the additional amount increased.
- Consolidated Grade Card & Provisional Certificate (by the University) will be issued only to the candidates who have satisfied the academic requirements for the award of degree.
